The program offers free roadside assistance for you and your family. Also included is free legal counseling and no denial life insurance policies, regardless of your current health. These are just a few of the items this partnership will offer our members. Each member will be receiving an IUOE Local 181 MCL booklet in the mail in the next two to three months which will include all the benefits available through this program. Brothers and Sisters, this will be a benefit the Local will provide for each member at no charge. Also, you and your family will have opportunities to add additional types of coverage and benefits with MCL at discounted rates to you.

The Local is financially strong with over \$14 million in total assets, and work hours are nearly 20% higher than they were this time last year. JATC is reviewing and approving investing in equipment at each quarterly meeting. As well as looking into new types of training to offer at the sites for our members. Local 181 is moving forward Brothers and Sisters.

This is why the Local has partnered with an advertising group to help Local 181 and our Apprenticeship program gain additional recognition for what we stand for, which is a remarkable opportunity for a career an individual can be proud of with amazing benefits. Additionally, we plan to

B. A.'S Work Reports

DISTRICT 1, HENDERSON, KY

The work in District One is plentiful and looks to remain steady until the season change and rain sets in.

In Henderson County, Ragle, Inc. is doing the Ohio River crossing with approximately 25 operators on site. Hazex Construction Company is still at the Henderson County Sports Complex utilizing around six operators. Most of the union contractors at Pratt Paper are winding up, with C. R. Meyer & Sons Company and Superior Concrete Constructors working just a

few operators.

In Hancock County, State Group Industrial is at Commonwealth Aluminum working a three-week outage that began in mid-October, utilizing several operators. Other contractors working at Commonwealth Aluminum are Lutaring Brothers and Hodskins Services, who have various small jobs for the next three months.

In Daviess County, Deig Brothers Lumber & Construction Company was awarded the Carter Road Wastewater project and began working the middle of October, with the possibility of work to the end of the year. Bowen Engineering Corp. was awarded the West End Wastewater plant, and we have a few operators on site. Bobby Luttrell and Sons are working on a few projects for the Regional Water Resource Agency running vac trucks.

Work in the Southern part of District One has been good throughout the summer months. Berkel & Company Contractors finished their portion of the new Envision Battery Plant in Bowling Green in early July. Midwest Steel was set to complete the erection of the building in mid-October with hopes of getting more bid work inside the structure. Barnhart Crane and Rigging has also bid work inside the plant. There are plans for at least two more buildings on that site, and Local 181 is hopeful that our Union contractors will be successful in bidding.

Also in Warren County, The Boldt Company has had some steady work at the GM Assembly Plant and has some more work planned for the rest of the year. Some of the work will go into 2024 and will utilize two to three operators. This should include the outage work and some roof work.

In Butler County, Sierra Bravo was

awarded the Real Alloys Landfill project that started in late September. This work should last into the latter part of 2024, employing eight to ten operators. Sierra Bravo will be utilizing a lot of GPS equipment on this project. It is important our operators take advantage of our training sites to keep their skills sharp.

In Muhlenberg County, Azco, Inc. continues the construction of the new TVA Simple Cycle Gas Plant with a few operators. That project is scheduled to be completed by the end of this year. The combined cycle has had a few outages this year employing a few operators with Atlantic Plant Maint., G-UB-MK and Maxim Crane all performing work there. Fisher Contracting is still moving forward with the Gypsum Stack project and has more work to come. D H Griffin Wrecking Company has started phase three of the demolition of the coal fired plant and work should continue into late 2024 employing eight to ten operators.

The need for certified crane operators has been unreal for Local 181 this year and looks like it will continue to stay in demand for a long time. We strongly recommend getting to the training sites and working on those certifications.

In closing, we would like to remind everyone that our monthly District meetings (except June and December) are held in Henderson, Kentucky, at the Headquarters Office on the first Tuesday of the month at 7:30 p.m., and at the Bowling Green, Kentucky office on the second Tuesday of the month at 7:30 p.m.

Work in District Two has been very strong with a good mix of Heavy/Highway and Building work. Although the work has not even begun to peak with a handful of large infrastructure projects set to begin next year.

The work being performed in District Two is as follows: McIntyre Brothers and Sevenson Environmental continue to work at GM Foundry. Mitchell Quarry is still mining rock every day. Bowen Engineering and Nicholson Construction are still on site at Crane Naval Base and Mr. Crane is working on the Underwater Missile Test Facility. Milestone Contractors, Calcar Paving and E&B Paving all continue working on multiple paving projects in the northern counties.

At Sabic, general maintenance is being performed by BMWC Constructors, Mel Kay Electric Company, and Sterling Industrial as they continue with capital projects. Russell's Excavating has the contract for the site mowing and snow removal. Also, Hayden Wrecking is still on site with more demolition work coming after the first

of the year. At Country Mark Refinery, contractors on site include: BMWC Constructors, Deig Bros., Mel-Kay Electric Company, and Russell's Excavating. Reynolds Construction is wrapping up the sewer line project in the Posey County area with a couple of directional drill companies on site. Bowen and Sterling Industrial continue maintenance work at the Gibson County-Duke Plant. W. B. Koester Construction has ash pond work at the Duke site and the work should last two to three years. Blankenberger Bros. also has ash cell work at AB Brown. Toyota will continue to have small projects and some weekend work through the end of the year utilizing Custom Mechanical Construction, Tron Mechanical Inc., L.G. Fox, State Group Industrial, Sterling Industrial, and Mel Kay Electric Company. Sterling Industrial is performing the maintenance work at IPL Petersburg along with several other contractors. Debra-Kuemple is still working on the wastewater treatment plant in Pike County. E&B Paving and J H Rudolph both have several ongoing paving projects in Posey, Gibson, & Pike counties. W. B. Koester Construction and Ragle Inc. both have a number of road and bridge projects in these areas. Pike, Posey, and Gibson counties should all have large solar projects starting within the next six months.

Infrastructure Systems is wrapping up water line projects in Tell City and Evansville. JBI Construction is working on the Epworth Road project in Newburgh. While E&B Paving and J. H. Rudolph have various paving project within the district. At Cleveland Cliffs, Graycor Industrial, Tron Mechanical Inc., Mel-Kay Electric Company, Kennedy Tank & Manufacturing, and State Group have all had various small maintenance projects that should last to the end of the year. Entact is closing out an ash pond at AEP Rockport and work is projected to last through 2024. Enerfab Industrial has maintenance and outage work at the site as well. Warrick county has an abundance of activity at the ALCOA - Kaiser Aluminum plant

site. Companies onsite include Sterling Industrial, BMWC Constructors, State Group, Enerfab Industrial, Klenck Company, Keller North American, Berkel & Company Contractors, Capital City Crane Rental, Graber Crane Services. and Maxim Crane Works, all continue working on the new projects at Alcoa. Sterling Industrial has maintenance work at ALCOA, Kaiser and AGC Power Plant. Bowen Engineering Corp. continues work on the new wastewater treatment plant at Alcoa which should last into next year. The F.B. Culley Station Power Plant has Sterling Industrial, Graber Crane Services, and Ash Management Services conducting various projects. Furthermore, Ragle Inc. has multiple projects in Warrick and Vanderburgh counties. In the Evansville/Vanderburgh County area there are waterline upgrade projects being performed by Infrastructure Systems, Blankenberger Bros., Deig Bros., and Ragle Inc.

In Closing, we would encourage everyone to attend the monthly district meetings held the first Tuesday of the month at 7:30 p.m. (except for June and December). We would also like to remind everyone to check your certification and drug card expiration dates, while continuing to upgrade your skills at the training site. We are extremely low and will continue to be low on CCO operators, so we would encourage anyone who is interested in crane work to visit the training site and get your certifications. We would also like to thank the Lynnville Training site staff and all the volunteers for all the work at the Labor Day events. If we can be of any assistance, please feel free to call at 812-474-1811 and do not forget we always need volunteers at the Fantasy of Lights events.

District 3 has been very busy to say the least. The work stretches all across the district utilizing many Indiana Highway contractors. These projects range from milling to new construction.

Milestone is in the final phase of replacing the bridges on I-74 and has various other projects throughout Southern Indiana. Dave O'Mara has several ongoing projects in the area. Such as, they are completing the Greensburg Airport and several bridge and paving projects throughout our District. Force Construction Company also has several bridge rehab projects in Brown and Bartholomew counties in Indiana. Lutgring Bros. is in the third phase of the new State Road 64 project with American Contracting starting on the new bridge portion for this project mid-October. W. B. Koester Construction remains at Galliger Powerhouse, with approximately two years of work remaining. E&B Paving continues the I-71 road widening project in New Castle, Kentucky utilizing approximately 30

operators. The work should last until mid-summer 2024.

District 3 has several mass excavation projects underway. Projects include, Turner Contracting has a new cell opening project at Rumpke Landfill in Brownstown, Indiana starting in April 2024, as well as a stripping project at Riverside Quarry in Battletown, Kentucky. Lutgring Bros. has an ongoing stripping project at Hilltop Quarry in Battletown, Kentucky. Also, Lutgring Bros. is bidding Phase II, which is expected to begin in April 2024.

Bowen Engineering has an ongoing wastewater project in Lawrenceburg, Indiana and a substation at Ford BOSK in Glendale, Kentucky. They are still working at Kentucky Utilities Ghent, LG&E in Trimble County and LG&E Mill Creek employing 15-20 operators and the work is expected to last into next year. Also, Bowen Engineer Corp. has a sewer project in Columbus, Indiana expected to last for over two years utilizing a few operators. R. B. Jergens Contractors should be finished with their two-year project for the ash pond closure at Clifty Creek Powerhouse in Madison Indiana by mid-November.

Berkel and Company Contractors have a micro pile project at Lotte Aluminum in Elizabethtown Kentucky that is scheduled to finish in early November. Berkel is also starting work at North American Stainless with 96 auger cast piles utilizing seven to eight operators. This should be completed by year end. In addition, Keller North America is also at Lotte Aluminum on a separate project working with over

40 operators.

District 3 has some pipeline work going on in Lebanon Junction, Kentucky. Foltz Welding has laid and welded 900 feet of 24-inch pipe with a 600 foot under the road bore. Maxx HDD is a subcontractor to Foltz and will perform the underground bore working approximately five operators. There have been projects with Otis Minnesota Services, Integrity Kokosing over this past season also.

Phillips Hardy is still at Nucor Brandenburg with ongoing site work employing around 25 operators. This work should last until January. The Harper Company is finishing up at the Louisville Airport, building a taxiway to the new 747 hangar. Likewise, E&B Paving continues to work at Louisville Airport on the Geothermal field and Lima taxiway employing about 20 operators.

The Ford Blue Oval project in Glendale, Kentucky continues to move forward at an astounding pace as we approach 600 Operating Engineers on site. Dozens of contractors who have been onsite have utilized Operating Engineers. To date, 8 million cubic yards of fill have been placed and over 300,000 cubic yards of concrete have been poured, running three onsite concrete plants around the clock. Tens of thousands of tons of structural steel has been erected. Miles of drainage pipe and box culverts have already been installed. Building #1 has been fully erected and now has an army of operators,

as well as multiple other crafts working on the interior and all these numbers continue to climb daily. The size and scope of this project is hard to believe as it grows and changes daily. The crawler crane booms are visible for miles as you drive down Interstate 65. There is no doubt there will be large additions to this site for years to come. It is a truly impressive site to see Local 181 Operating Engineers building the future and creating jobs in the heart of the Local. Manpower will continue to grow and will have a large need for more highly skilled Local 181 Operating Engineers for years to come. We are building the future

of Local 181 one member at a time.

District 3 would like to remind everyone there is an important Kentucky Governors election coming up in November. Please acknowledge the current unprecedented economy throughout the Commonwealth. At no time in history has there been as many projects ongoing throughout the Commonwealth with Union members working on them as there are to date. Governor Beshear has stood with Labor, and now we should stand with him.

We welcome all Members to come out to the District 3 monthly meetings. The first

Tuesday of the month in Louisville, Kentucky and the second Tuesday of the month in Hayden, Indiana. In closing, I want to thank all the hard-working Members who have traveled to the district to help with the work.

Thank you to all who attended the Labor Day picnic at Boonesborough State Park. We had a good crowd, good food and a good time spent with the brothers and sisters of Local 181. Please make plans for attending our 2024 picnic.

Work across District 4 has been pretty good with several small jobs spread out all over the district. Schnabel Foundation Company is in Breathitt County at Pan Bowl Lake utilizing two to three operators. In addition, they are also working a couple of operators in Perry County on a drilling project setting caissons.

Maxim Crane Works has a job in Marion County at Pernod-Ricard Distillery, setting tilt up walls with

a 65-ton picker and an 18,000 Manitowoc with three operators on the project. Also, Babcock & Wilcox is working on a project at East Kentucky Power in Maysville. They are performing a super heater change-out with three operators and will be adding additional operators by the time of this article's publication. This project should last until November.

Ryan Inc Central has finished up a flyash cell this summer. However, another flyash cell is bidding, and they are currently waiting to see who has been awarded the project. If it goes well, they will need around ten operators and it should start after the first of the year.

Contractors in District 4 are bidding aggressively on multiple projects in our area. If awarded, it will be a great end to 2023 and a strong start for 2024. We have some good work coming in 2024 with the Wolfe Creek Dam project already awarded to American Bridge Company. They are fabricating the gates currently.

Toyota, in Georgetown, has calmed down for the time being but will have picked up some in October and again with a shutdown around Christmastime. There will be more work in the Spring. Little Creek Construction is working every day in Lexington installing water lines with 14-16 operators. Little Creek Construction is also continuously bidding on new sections of the water line.

Miller Pipeline is doing distribution work in Winchester, Mt. Sterling, Paris, Frankfort, and Lexington. While Whittenberg Construction Company is in Midway doing rack houses for Woodford Reserve. They have a couple of operators working and Padgett will be doing the tilt-up walls when Whittenberg has the concrete poured and ready.

Come to your Union meeting and keep up on what is going on around the district. Be sure to keep current on all your certifications and utilize the training center. Getting more training, getting more certifications, especially CCO's will open so many more opportunities for our members.

The work in District Five has been the best we have seen in several years with additional work on the way. The work for Jim Smith Contracting has been plentiful, and more work is coming this fall with the Highway 60 project and other paving projects throughout District Five. The Wingo exit job has had several operators working throughout the summer. In addition, work is also scheduled on the I-69 improvements located in Graves and Hickman Counties.

The work at TVA Shawnee Steam Plant has been strong with the SCR Project starting to ramp up with G-UB-MK. The fall outage season is coming, and G-UB-MK will have several operators on site. Kiewit Construction is slowing down and will try to complete the Ash Closure project this winter, and the Solar Farm project should begin in the Spring.

The work in Calvert City should be strong for 2024 with Arkema, Inc., planning on a large expansion of the new environmental freon line in the spring of 2024. Westlake will also have work coming up in the spring with the Slurry Wall project. Please, all members in District Five, get your hazmat





certification. All operators on this project will need to have the hazmat certification.

Ascend Elements in Hopkinsville, Kentucky, has eight to ten contractors on site, with more expected in the fall. Please make sure you have a current BOLT card, and your certifications are up to date to work on this project. We also expect several carrydeck and forklift jobs in the spring.

We want to remind everyone to take advantage of both the Boston, Kentucky, and the Lynnville, Indiana training sites to upgrade skills and obtain certifications and re-certifications. Please call first to check on overhead and fixed cab CCO certifications at either site if you are interested in operating cranes, as these certifications are in demand.

DISTRICT 6, CATLETTSBURG, KY

It has been a busy year in District 6. As I am writing this newsletter, we are dispatching to Marathon Catlettsburg Refinery for the fall outage. Deep South Crane and Rigging will need 50 - 60 operators, in addition to keeping year-round hands at the shop. Global Scaffold Construction and Turner Industrial Maintenance have also kept operators in the Refinery.

Allard Excavation has kicked off the Winchester Avenue, Roundabouts project in Ashland, Kentucky. The project consists of installation of five (5) roundabouts, new curbs, and gutters from 13th Street to 22nd Street. The project will keep five to six operators busy for the next year.

Construction is continuing at Sandy's Racing and Gaming at Camp Landing Entertainment District (formerly the KYOVA Mall) in Cannonsburg, Kentucky. Early Construction Company has four to five operators on site. Sandy's will have 40,000 square feet of gaming space with over 700 slot-like games and is expected to attract thousands of visitors to the Tri-State area, coming this Fall!

Construction has begun on the new Emergency and Imaging facility at King's Daughters Medical Center in Ashland, Kentucky. Grout Systems has three to four operators installing the foundation elements, and Maxim Crane Works has a couple of operators on site running a 777-crawler crane.

C.J. Mahan Construction is at Cave Run Lake working on the Raw Water Intake Project; this will possibly last into Spring 2024 keeping several operators on site. Little Creek Construction has an ongoing project in Greenup, Kentucky installing new waterlines. This project is scheduled to last up to five months and has three to four operators. Mi-De-Con has had various maintenance projects throughout the year at Calgon Carbon as well as a hydro project at Greenup Locks and Dam that has employed six to eight operators.

We finally had a Union contractor, Contractors Rental, awarded one of the many Abandoned Mine Land (AML) projects let in District 6. Contractors Rental has kept two to three hands on the Mark Riddle Landslide (AML) Project located at Rush, Kentucky. We are hopeful that more union contractors will bid and win.

Triton Construction continues to progress on the US 460 bridge over Pond Creek, which is the tallest bridge of any kind in Kentucky, measuring 324 feet from the creek bottom below to the top of the bridge deck at centerline. For comparison purposes, the bridge is 18 feet, 9 inches taller than the Statue of Liberty. The project is working 11-12 operators and will continue until Spring 2024.

In closing I want to personally thank everyone that came out to show support and celebrate Labor Day with us! Members participated in the Catlettsburg Labor Day Parade and enjoyed the first picnic held at District 6's newly constructed shelter. We wish to see the turnout grow each

year! I hope to see you at the next Union Meeting and remember this is your UNION! If I can help you in any way, come visit or give me a call.

APPRENTICESHIP & TRAINING

Training at both Boston and Lynnville sites has been picking up as we go into the fall. At the time of this writing, Boston has 121 apprentices and Lynnville has 98. That is 45 more apprentices than this time last year. We have a lot of new operators working in the field, so if you get a chance, help a young brother or sister by showing them the right way to becoming an Operating Engineer.

With the high demand for operators all over the Local, the workload has also increased the activities and training provided at the training sites. Both sites are constantly attending career fairs, school functions, and hosting school site tours to inform students about our great career opportunities. The sites have had multiple interviews and orientations this year, in an effort to keep up with the demand for apprentices.

The implementation of a Kentucky State Track Program direct-entry process in collaboration with local vocational schools has been a major asset in finding candidates for the apprenticeship program. Hopefully, all our efforts to network with more schools and programs will aid with meeting the need for new brothers and sisters in the training program.

The JATC is committed to improving the apprenticeship and training program as we move forward. At the last JATC quarterly meeting, a vote was taken to rescind the seat time hour requirements on the small carry deck crane (TSS) allowing members to pursue their CCO certification. However, the JATC requires a member to show proficiency on this crane and complete the NCCCO requirements to be able to obtain this certification. With that being said, the Board voted to update and have two Broderson carry deck cranes at each site, so we can accommodate the higher demand for certifications.

The Board recently approved the purchase of a new mini excavator and two new skid steers for the Boston site. One of the new skid steers has a grader blade attachment and is equipped with Trimble GPS (Earth works). The second skid steer is an update to our current equipment. While in the process of

upgrading our equipment, the Boston site has been approved to sell two of the sites carry deck cranes and purchase a Broderson IC80 and Broderson IC200.

The Boston site is getting ready to start our mandatory apprentice training classes in November. We must start earlier this year due to the increase in the number of apprentices. The early start-up date will allow us to keep the class sizes at a manageable group size. Not only is it better for offering quality training, but the early start and smaller class size will hopefully relieve the challenge of replacing a working apprentice who must leave the worksite to attend mandatory training. Therefore, we will be starting earlier and running classes longer than in years past.

The training calendars are out and available on IUOELocal181.org website. If a member wants to attend any classes, please call the hosting site to reserve your seat.

As always, please keep up with your certifications and attend one of the training sites and brush off the rust and/or learn new skills. We always tell our new apprentices the more you learn, the more you earn. That statement goes for all of us.


